At a Meeting of the Provincial Crand Loage of Leicestershire, held at Leices er, on Wednesday, the 3rd of June, 1857 the Right W. Brother William Kelly, D. F.G. M., in the Chair, the following Rules and Regulations were unanimously adopted as the By-Laws of the Province, and were subsequently duly confirmed.

In addition to the Laws contained in the Book of Constitutions, having reference particularly to Provincial Grand Lodges, the rules and regulations laid down therein for the government and management of the United Grand Lodge of England shall be construed as, and held applicable for the same purposes in this Provincial Grand Lodge, in all cases except those specially provided for in the following rules.

I.

Former By-Laws repealed.

All By-Laws heretofore made for governing and regulating the Province of Leicestershire, and the Provincial Grand Lodge thereof, shall be, and the same are, hereby repealed.

II.

Quarterly Communications to be held.

The Provincial Grand Codge of Leicestershire shall be holden quarterly, by the R. W. Provincial Grand Master, or his Deputy, in the months of January, April Luly, and October, for the despatch of the Masonic business of the Province, and for other purposes hereinafter mentioned: the Lodge in the month of October to be the Annual General Meeting.

At these meetings brethren not members of this Provincial Grand Lodge may, by permission of the R. W. Provincial Grand Master, or his Deputy, be present, but on no account can they be permitted to vote or speak on any question under discussion by the Grand Lodge.

III.

Lectures, &c., to be worked.

The regular working of the Lectures of the several degrees of craft Masonry being very desir able, and absolutely essential to enable the younger members of the Order to become duly instructed in our mysteries, and for which there is seldom time at the regular meetings of private Leages; whilst, by the Lectures and ceremonies of the Order being worked at periodical meetings, composed of members of all the Lodges in the Province, Juniformity of working would be insped; some portion of the Lectures or Ceremonies of the Order, as the R. W. Provincial Grand Master, or his Deputy, shall from time to time appoint, shall be worked at each of the three quarterly Communications in the months of January April, and July. It shall also be competent at such meetings for any of the Brethren, with the sanction of the R. W. Provincial Grand Master, of his Deputy, to deliver original Lectures on the history or symbols of the Order.

IV.

Annual appointment of Officers, &c.

The Auditors of the Treasurer's accounts shall make their report, and the Provincial Grand Officers

shall be appointed, and the Provincial Grand Treasurer elected, at the annual Provincial Grand Lodge in the month of October, except when vacancies may meantime occur, then and in such cases, the vacancies of office so occurring shall be provided for as the circumstances demand and the Book of Constitutions directs.

V.

Members of the P. G. Lodge to wear their proper clothing.

No member of this Previncial Grand Lodge shall attend therein without his proper jewel and clothing, according to his mak, and every brother appointed to office therein shall, previously to the next Quarteriy Communication, provide himself with, at least, the undress clothing suitable to his office, and, in default of so doing, his office shall be declared vacant, and any rank or distinction acquired in consequence of his appointment forfeited.

VI.

Non-attendance of P. G. Officers.

Any Provincial Grand Officer having failed to attend in his place at the annual Provincial Grand Lodge, shall lose his title to that rank as a Provincial Grand Officer, which he would otherwise have acquired in virtue of the appointment made for that year, unless good and sufficient reason be assigned. And if any Provincial Grand Officer shall join the Provincial Grand Lodge meeting after the hour named in the summons, and when anothe Brother shall have been appointed to occupy the vacant office, then and in such case, it is deblared, that such Provincial Grand Officer, being thus wanting, shall lose his right, pro tempore, to act as a Provincial Grand Officer.

Vda

The P. G. Treasurer's Duties.

The Provincial Grand Treasurer shall receive all contributions from the several Lodges in the Province, and all Fees, Fines, and other Moneys payable to the Provincial Grand Lodge, and enter such moneys so received, and all payments and dispursements he may be required to make, for and or account of the Provincial Grand Lodge, in a book set apart for that purpose, which book shall be produced at every Provincial Grand Lodge: and further, the Provincial Grand Treasurer shall also, at the Annual Provincial Grand Lodge, along with such book as before-named, produce and exhibit his financial statement of receipts and pay-

ments, and all vouchers for disbursements, and which books and accounts, vouchers, and papers, shall, prior to such Annual Meeting, have been examined by the Auditors to be annually appointed for that purpose, or, in default of such appointment, by the Provincial Grand Registral, and Provincial Grand Superintendent of Works, who shall severally affix their names to the Provincial Grand Treasurer's statement of receipts and payments, and report thereon to the Provincial Grand Lodge, and a copy of such statement shall be transmitted to the Lodges within the Province: and it is further provided, that the Pravincial Grand Treasurer, whensoever rectified by notice in writing from the R. W. Provincial Grand Master, or his Deputy, shall produce all the books, papers, and vouchers connected with his office as Provincial Grand Treaarer, and surrender possession of the same.

VIII.

All Accounts to be signed by the P. G. M. or his

Deputy.

The Provincial Grand Treasurer shall not pay any account whatever, connected with the Provincial Grand Lodge, without the sanction of the R. W. Provincial Grand Master, or his Deputy, conveyed by his signature being affixed to the document or voucher so paid.

IX.

P. G. Registrar's Duties.

The Provincial Grand Registrar shall superintend the preparation of all patents, dispensations and other documents, issued by authority of the R. W. Provincial Grand Master, or his Deputy, in conformity with the established laws and regulations of the Order, and only register the same. He shall examine the Manute Book and By-Laws of the several Lodge in the Province, and report thereon accordingly, if a ything therein appears contrary to the laws and disages of the Craft, in order that due investigation may, when needed, be made into any irregularity or impropriety occurring. (See also Rule VII.)

X

The P. G. Secretary's Duties.

The Provincial Grand Secretary shall issue summonses in proper time for the meetings of the Provincial Grand Lodge, make minutes of the proceedings at such meetings, and, under the direction of the R. W. Provincial Grand Master, or his Deputy, report the same to all the Lodges in the Province; receive the returns of contributions from the several Lodges in the Province, and pay over to the Provincial Grand Treasurer, immediately on the receipt thereof, any moneys for contributions, fees, or fines, which may be paid or sent to him from the several Lodges or Brethren. He shall keep a register in a book set apart specially for that purpose of the Brethren of the several Lodges in the Province, noting severally the periods of Entering, Passing, and Raising of the Brethren, and also the time of joining of Brethren, and, also, a list of the Master, Wardens and Past Masters in every Lodge; attend to all communications, reply to all letters, and otherwise support the R. W. Provincial Grand Master, and his Deputy, in all matters where epistolary aid is required.

XI.

The P. G. Superintendent of Works' Duties.

The Provincial Grand Superintendent of Works shall, in addition to the duties devolving on his office, as set forth in the *Book of Constitutions*, aid and assist the Provincial Grand Director of Ceremonies, when required, in the arrangements neces-

sary for the meetings of the Provincial Grand Lodge, and in the marshalling of Masonic processions. (See also Rule VII.)

XII.

P. G. Director of Ceremonies' Duties.

Provincial Grand Director of Ceremonies' delice.

Addition to the other of the delice of the deli The Provincial Grand Director of Oremonies shall, in addition to the other duties appertaining to his office, as set forth in the Book of Constitutions, have the charge of, and be accountable for the safe keeping and good condition of the furniture, jewels, paraphernatia, clothing, and all other such property, belonging to the Provincial Grand Lodge; and in no wise shall the Provincial Grand Director of Caremonies grant the use or loan of any such article or thing, thus committed to his trust, without the anction and approbation first had and obtained of the R. W. Provincial Grand Master, or his Deputy; and it is hereby provided, that if such jewel and clothing which may thus be granted to any P. Grand Officer, or Past P. Grand Officer on loan, be not returned within the space of fourteen days, and in as good condition as when received, such Brother shall be subject to a fine of Ten Shillings, or shall be amerced to the amount of the damage done to such jewel and clothing, as the case may be.

XIII.

The P. G. Pursuivant's Duties.

The Provincial Grand Pursuivant, in addition to the duties assigned to him in the Book of Constitutions, (Art. 5, p. 39, ed. 1855), shall prove the qualification of every Visitor not otherwise satisfactorily vouched for.

XIV.

The P. G. Tyler's Duties.

The Provincial Grand Eyrer, when summoned, shall attend his duties at the Provincial Grand Lodge meetings, and shall act as Servitor at the banquet; and, when so attending, shall receive for each Annual General arceting the sum of Seven shillings and Six-pence, and for each Quarterly Communication the sum of Six shillings; and when the Provincial Grand Lodge shall be held out of Loicester, he shall be further paid his travelling expenses to and from the place of meeting on each occasion.

XV.

The W. Masters of Lodges to vouch for their respective Members.

The Worshipful Master of each private Lodge, or in his absence the senior officer of his Lodge

present, who is a member of this Provincial Grand Lodge, shall answer for the qualification of every member of his Lodge attending a meeting of this Provincial Grand Lodge.

XVI.

Notices of Motion.

Every notice of motion intended to be brought open Lodge, and be entered open Lodge, and inserted in next meeting and inserted in the meeting of before this Provincial Grand Lodge, must be given in open Lodge, and be entered on the minutes of the meeting, and inserted in the summors calling the next meeting, at which the motion must be brought under consideration or it will be taken as abandoned. Every Tember giving notice of a motion must ascertain that it be duly entered on the minutes, or take the risk of any irregularity that may occur through error or misunderstanding. Provided always, that the R. W. Provincial Grand Master of his Deputy, may bring forward, or permit to be brought forward, at any time, any notion that they may deem advisable.

XVII

Contributions from Lodges.

Every private Lodge in the Province shall contribute and pay to the funds of this Provincial Grand Lodge, as follows:-

Six-pence per quarter, or Two shillings annually for each of its subscribing members.

Five shillings for each newly initiated brother, and One shilling for each brother who shall have joined the Lodge since its last return.

XVIII.

Annual Return of its Members to be raide by every Lodge.

A Return shall be made to the Provincial Grand Secretary by every Lodge in the Province, on or before the first day of February in every year, furnishing a list of all the members of the Lodge to the close of the preceding Masonic year, ending on the Festival of St. John the Evangelist, with the dates of every initiation, passing, and raising, which may have taken place since the last Return was made, and also the age, residence, title, profession, or calling, of every brother upon whom any of the before-mentioned degrees may have been conferred; and also the date when any brother shall have joined such Lodge, if any such there be; and setting forth the name and number, and place where holden, of the Lodge of which such joining brother was last a subscribing member; and such list of members of such Lodge to commence with the name of the brother who has been a contribu-

ting member of the Lodge for the longest period of time, and successively descending to the other members of the Lodge in like manner, and terminating with the name of that brother who shall have been a member of that Lodge for the shortest period of time-such list to be signed by the Worshipful Master and the Secretary of the Lodge. And it is further provided, that, in order to ascertain who shall be entitled to the right of membership in the Grand Lodge of Lagland, and the Provincial Grand Lodge of Leicestership a list of the Master, Wardens, and Past Masters of the Lodge shall be returned of the same time. And it is hereby provided that the contributions and fees arising and according to such Return aforesaid, and to the preceding By-Law, shall become due and payable at the Provincial Grand Lodge Meeting in July in every year, and shall pass to the Provincial Grand Lodge Fund, and be appropriated as is hereinafter provided.

XIX.

Disposal of the P. G. Lodge Funds.

The funds in the hands of the Provincial Grand Treasurer, arising from the various contributions, fees, and fines, payable to the Provincial Grand Lodge, as hereinbefore provided, shall be appropriated, in the first instance, to the payment of the expenses of the Provincial Grand Lodge, for furniture, jewels, clothing, tyler's fees, and other necessary charges, and afterwards to such charitable or other purposes as the Provincial Grand. Lodge may from time to time direct.

Appointment of Auditor

Three members of the Provincial Grand Lodge shall be appointed amoually at the Quarterly Communication in Judy, who shall audit the Treasurer's Account, as before provided in Rules 4 and 7.

ator to be admitted into any Lodge without due Examination.

ward our Lodges most effectually against the possibility of intrusion by impostors, the Worshipful Master of the private Lodges of this Province shall, each of them, from time to time, so caution and instruct his officers in their duty, that they may on no account suffer or permit any Visitor to enter their Lodge until he shall have produced his certificate from the Grand Lodge under the Constitution

of which he was made a Mason, "and not even then without due trial and strict examination or sure information from some well known brother," that he has been regularly made in a lawfully warranted Lodge. (See the Grand Lodge Return, dated March 1844.)

XXII.

Proposition of a Non-Resident Candidate.

Where any person is proposed as a Candidate for Masonry, and resides in another tewn in the Province where a Lodge is held, the Worshipful Master of the Lodge in which the proposition is made shall, if he think fit, cause the Secretary to make enquiry, either of the Worshipful Master of any such Lodge, or of some influential person in the town where the candidate resides, previously to the ballot being taken, so as to ascertain the candidate's character and moral fitness, in order to prevent an unworthy person from being made a Mason.

XXIII.

Proposition of a Joining Member.

Any brother seeking to become a joining member of any Lodge in this Province, shall not be admitted until due enquiry shall have been made, or until a satisfactory report shall have been received from the Lodge of which such brother was last a subscribing member, that all contributions. subscriptions, and fees, due by him to such Loage, have been regularly paid and discharged, and that such brother has not been, nor is there any cause why he should be, excluded from that or any other Masonic Lodge; and it shall be incumbent on the W. Master or acting officer of such Lodge in which such brother shall seek to become thereof a joining member, to make, or cause to be made, the foregoing enquiries; and the wewer, towning such brother in question, shall e read to the brethren in open Lodge assembled, prior to the ballot taking place for the admission of such brother as a joining member.

XXIV

The Book of Constitutions to be furnished to every Member of the Lodges in the Province.

That the brethren of this Province may have the opportunity of making themselves acquainted with the Laws and Regulations of the Craft, the W. Master of every Lodge in the Province shall, at the cost of his Lodge, procure and present, or cause to be presented to each of the present members and to every future member of his Lodge, a copy of the 1850 TICK latest edition of the Book of Constitutions of the United Grand Lodge of England.

XXV

Alteration of By-Laws.

No proposition for any new By-Law, xor for the alteration, repeal, or abrogation of any of the existing By-Laws of the Provincial Grand Lodge shall be received or allowed, unless due notice of such proposition shall have been sent, or given in writing, to the Provincial Grand Secretary, so that the same may be inserted in the Provincial Grand Lodge summonses, and transmitted to the several Lodges of the Province for their consideration: and at the next Provincial Grand Lodge meeting the same shall be determined by the majority of the members present, and when approved and confirmed shall become a By-Law.
