# Report for the year 1939-30.

Mark Masonry in the Province has made a distinct advance during the year, from the returns furnished by the various Lodges there are 31 new Members, against which we have lost 8 by resignation and 5 by death, a net increase of 8.

To this number has to be added the Members of the newly consecrated St. Laurence Lodge, vtx. 21 Founders, 1 Advanced

and 2 Joining Members, a present total of 24.

In the Royal Ark Mariner Degree the progress has not been so satisfactory, there have been 9 new Members against 8 resignations and 6 deaths, a net decrease of 5.

The total number of subscribing Members is now giver as 255 Mark Brethren and 172 Royal Ark Mariners. Due allowance, however must be made in these figures for Brother, who are subscribing Members of more than one Lodge in the Province.

The financial position of each Loage is reported as satisfactory.

The Province mourns the lost by dead, of the following distinguished Brethren, Wor. Bro. J. S. Cris, P.G.Std.B., P.P.G.W., Wor. Bro. A. G. Uglo, P.G.Std.B., P.P.G.W., Wor. Bro. W. J. Bridgwater, P.G.D., P.P.C.D., who owing to illness was unable to attend the Grand Festival for investment, and Wor. Bro. F. A. W. How, P.G.Ov

An interesting (vent took place of 26th July 1930 when the St. Laurence lodge, No. 9.7 was consecrated by the Rt. Wor. Prov. G. Master, assisted by the D.P.G.M. and Officers of Provincial Crand Lodge. There were 21 Founders and V. Wor. Bro. Charlie D. Eaton, P.C.Ov., was duly installed as the first Master

Lists for recording the contributions to the New Mark Premises Fund have been issued to each Lodge and should now receive the attention of each Wor. Master. The Province has pledged itself to endeavour to raise a sum equivalent to a subscription of £5 for every Mark Mason in the Province and it is expected that each Lodge will do its share in carrying cat this promise. Congratulations are extended to the W.M. and Brethren of St. Laurence Lodge in having already qualified for the Building Fund Collarette and Jewel and the Moseley Lodge is well on the way for acquiring the same distinction, an example which it is hoped other Lodges will not be slow in following. It may be mentioned that a contribution of £10.10.0 by any Brother entitles him to receive the special Jewel as well as assisting in providing the quota from his Lodge.

The Mark Benevolent Fund was again well supported, 16 Brethren qualifying as Stewards with a total contribution of £94.10.0.
