THE MOSELEY LODGE OF MARK MASTER MASONS No.667

The Moseley Lodge of Mark Master Masons No.667 was consecrated in the Moseley and Balsall Heath Institutute on Monday, the tenth day of September 1917. It is the fourth oldest in the Province of Worcestershire.

Much thought by a variety of eminent Freemasons went into the formation of this Lodge as is evidenced by the first Minutes in the original Minute Book.

A meeting of interested Masons was held at the Institute on Friday, hev 8th. 1917 to discuss forming a new Mark Lodge at Moseley. Fifteen brethren a tended and voted W.Bro. J. A. Hughes, Prov.J.G.W., (Warks) into the Chair. Consideration was given to proceedure and the many details to be undertaken to establish a new Iodge. The "XC/OSED" Chairman that " the necessary steps be taken to 'found' a Mark Master Masons Lodge in this District of the Province of Worcestership." The proposal was seconded by Bro. Thomas Mason and carried unanimously.

The choice of name lay between "Masefield" and 'Arter" which had been proposed or a more territorial one. The latter was decided upon a d'hoseley was adopted following the defeat of a motion in favour of "Fast horcestershire Lodge of Mark Master Masons. "W.Bro. Hughes was 'men nominated as the Worshipful Master Elect and Bro. A. C. Mason as Secretary pro tem, hoving already undertaken preliminary work.

At a meeting of sixteen brethren in the appendal Hotel, Birmingham on 6th. July following it was disclosed that the Artford Military Lodge of Mark Master Masons No.408, had offered the facilities of their Lodge to Advance candidates in order that they may become Founders of the proposed new Lodge and also, that the Master and Wardens would give their recommendation to a Petition.

The Hertford Military Longe duly met on the 23rd. of the month at the same hotel in Temple Street and fourteen Candidates were balloted for, elected and Advanced. All of these, with one exception, Bro. Walter Green, are named in the list of the Thirtyseven Founders.

There is a very full record of the arrangements, and a report of the meeting on the 20th. August states that after the preceeding minutes and report was read " the nomination of officers was proceeded with and the brethren thus honoured unanimously decided to present to the Lodge the Collar and Jewel of the Office assigned to them. The proposed By-Laws were considered and drafted to the approval of all present.. etc. The proposed Masonic Hall at Kings Heath was brought before the notice of the meeting which unanimously decided to support the proposal. These records are a faithful account of the proceedings which led to the consecration and constitution of the Moseley Lodge of Mark Master Masons No.667 on the 10th. day of September 1917

The Founders were marc'alled into their positions and W.Bro. J. A. Hughes, Prov.J.G.W., Warks. occupied the Chair and opened the Lodge. The Summons being read, the R.W.Bro. Lt.Col. Lord Athlumey, P.G.W., Prov. G. M. of Worcestershire, entered the Lodge with other Officer. on the Prov. G. Lodge of Worcs. He took the Chair and after appointing his Officers pro. tem proceeded to the Consecration and Constitution of the Lodge. There were present a tool of eighty Brethren.

After the Patriarchal Denediction was delivered the R.W.Provincial G. Master left the Chair which was then occupied by W.Bro. C. P. Perry, P.P.G.W. (Staffs), who Installed W.Bro. John Alber; Hughes, P.J.G.W. (Warks) as the first Worshipful Master of the Lodge.

Nollowing the appointing and investing of the Officers and various propositions in is recorded that " The W.M. in thanking the Conse'g Off. The R.W.Bro. Lt.Col. Lord Athlumney, Prov.G.M. on behalf of the Lodge for being present to Consecrate the Lodge & his munificent gifts of BIBLE, CUSHION & WORKING TOOLS, eulogised his services to M.M'y in general and the Prov. of Worcs. in particular & presented to him a Cons'y Officers Jewel & honourary membership of the Lodge.

The W.M. also thanked V.W.Bro. W.J.Page, Dep.P.G.M., V.W.Bro. Rev. Father Down, P.G.Chap W.Bro. J. Jones, Prov.G.Sec., W.Bro. C.D. Eaton, P.G.Sec. (Warks), D. of C., W.Bro. J. E. Rowley, P.S.G.W., & Bro. B.W.F. Whittaker, P.G.I.G., for their attendance and assistance & in presenting them in turn with a Consecrating Officers Jewel desired them to accept hon. membership of the Lodge.

The W.M. called Bro. A. C. Mason, Organist to the pedestal, thanked him for his services & strenuous work in connetion with the formation of the Lodge and presented him with two Bound Volumns & a Consecrating Officers Jewel.

A very full account of this Consecration fills eight pages of the Minute Book.

The meeting of 5th, Nov. 1917 was attended by 28 members and 11 visitors. Following the usual salutations the Chaplain recited the Special War Prayer. Then a ballot was taken for five candidates for advancement. The Advancement Fee (inclusive) being two guineas and the Annual Subscription one & onehalf guineas, a Joining Member Fee was also set at one guinea. It may also be of interest that a Visitors dining fee at installation meetings was seven shillings and six pence, at ordinary regular meetings five shillings. The very neat, hard backed By-Laws printed by The Birmingham Lithographic Co. Ltd., commence with a list of Founders and Hon.Members, and then "PREAMBLE

Three candidates mentioned above were advanced that (vering. Then attention was drawn to a circular respecting the Moseley Masonic Hole Co. Ltd. which was in course of formation, and a resolution was carried to invest ive pounds from Lodge Funds in that company.

The Lodge was cast into mourning by the death of the Worsh of Master, W.Bro. J. A. XMMM Hughes, P.P.G.W. Warks., and the Summons for the Meeting of the 4th Mar. 1918 bears a black mourning border. That evening the Fineral March to rendered while the members stood in silent tribute to the departed Brotner. W.Pro C.P.Perry occupied the Chair and on the 3rd. & 4th. Risings made r. most eloquent tribute to him mentioning that he had been chosen to fill the important position of Grand Treasurer " for which Office he had been nominated & would und notedly have been elected ". " W.Bro. Perry then moved the following resolution

Hammond mentioned the lack of support brethren of the Lodge were extending to the purchase of equipment for the New Masonic Hall at Kings Leath, & urged the Brethren in view of the interest which the late Wor.Bro. tok in the matter, to come forward and invest their money & provide a sum which would be a credit to the Lodge. "

V. Bro. W. B. Varmond, P.M. 408, P.P.G.W. (Warks), Prov.G. Sec. (Warks), S.W., M.E., was Installe as Worshipful Master on Monday, Sept. 2nd. 1918 in the presence of many exalted brethren, including W.Bro. Canon C.W.Barnard, M.A., P.G. Chap., D.P.G.M. (Warks).

This was the first Regular Meeting held at the Masonic Hall, Institute Road, King's Heath. Up to now the meetings were held at The Moseley and Balsall Heath Institute, Moseley, and the Officers Intermediate Meetings were held at the Imperial Hotel, Temple Street, Birmingham.

There is a relevant minute recorded from the 4th. Intermediate Meeting held at the Imperial Hotel on 22nd. July 1918 which reads " The Sec'y was instructed to write the Prov.G.Sec'y for permission to remove the place of meeting to The Masonic Hall Institute Road, King's Heath & to acquaint the Clerk of the Peace of the removal. "

The Great War ended with the Armistice of 11th. November 1918, and in those few months of the existance of the Lodge prior to that date, two of the members had suffered, one having a son killed in action, another having a son severely wounded. The death of the only son of Bro. & Mrs. A.C. Mason led to a resolution minuted at the Intermediat. Meeting of the Officers on Tuesday,Oct. 15th. 1918, "As the next Meeting of Prov. G. Mark Lodge was to be held under the Banner of the Moseley Mark Lodge No.667, it was resolved that the collection at same, should be devoted to the Worcesters'in Prisoners of War Fund, subject to the sanction of the Prov. Grand Master. "This was given, and the collection donated thereto.

The eventful Meeting of the 4th.November 1918 was opened at 3.45.... b) W.Bro, W.B. (Hammond, Master, assisted by thirty members and twenty visitors, which included W.Bro' Lt.Col. Z. Walker, D.P.G.M. (Warks.). The Lodge proceeded with the work uptor and including, the advancement of Bro. G.M.Hind, following which. The R't Wors ipfal Prov. Gwand Master & the Officers of Provincial G. Lodge were then announced, to be escorted into the Lodge by all Present & Past Prov. G. Officers already attend of.

The R's Wor. Prov. G. Master, . Lt.Col. Lord Athlumn v assumed the Chair and opened Prov. Grand Lodge. When it was closed, the work of M. seley M. Lodge was resumed and closed in time for Supper prepared for seven o'c.ock.

January 6th. 1919 was the date of the next Meeting, the Lolge being opened at 6p.m. This being the first held following the Armitice the Worshipful Master called on the Chaplain to offer up The Special Thanksgiving Trayer, and then the Doxology was sung, "Glory to God in the Highest".

On the 2nd. Rising the Sec. read a letter " received from the Prov. G. Sec'y stating that the R.W. Prov. Grand Master, Pro.LA.Col. Lord Athlumney was compelled to resign his position as Prov. G. Master on account of this daking up residence in Ireland. " This led to the appointment of M Bro. W. 1 Pige as Prov. G'd Mark Master. Formation of a Royal Ark Marin r Lodge in connection with this Lodge was proposed by the Worshipful Master that sale evening and a committee of three was formed to make the necessary arrangement. In order to report at the next meeting. A Minute of the Meeting of Monday, 3rd. March 1919 re.ds " In accordance with Notice of Motion, the W.Master moved that sale ion be given to I a New Lodge of Royal Ark Mariners to be attached to this fodge, & that the Petition and make arrangements for the formation and consecration. ' This proposal was carried.

The Charity Dex of this evening, augmented by a sum from the W.M. and made up to a total of finteen guinees from the Charity Stewards A/c. was balloted for in three guinees shares for the corthooning Annual Festival of the Mark Benevolent Fund to be held on the 25 h. June 1915

At an energency Meeting of the 5th. May 1919, the "Wor. Master announced that in connection with the formation of the proposed R.A.M. Lodge, arrangements had been made to revate those brethren desirous of becoming Founders, at Dudley on May, 15th. under the Banney of the Abraham Green Lodge of R.A.M. "

Bro. Thomas Mason, Prov.G.S.O., S.W., Master Elect was Installed at the 9th. Regular Meeting on Monday, Sept. 1st. 1919, in the presence of V.W.Bro. Wm. T. Page, P.G.O.Eng., Deputy Prov. G.M. in Charge. Correspondence was read relating to the marriage of V.W.Bro. Lord Athlumney, late Prov. G. Master, and the presentation of a suitable gift on behalf of this Lodge and the other lodges concerned, for which a letter of grateful appreciation had been received. The Minutes of the Intermediate Meeting of the P.M's & Off's which was held the previous month contain an interesting item, it being announced by the W.M. that "W.Bro. Zaucheus Walker, V.D., J.P., was to be installed as Prov. G. Mark Master of Warwickshire and W.Bro. Walker had been pleased to appoint one of the members of this Lodge, V.W.Bro. Felix Jones, P.G.Treas., as his Deputy. "

In the month of November R.W.Bro. Lt.Col. Z. Walker, accompanied by his Prov.G.W., W.Bro. W. A. Bibb, attended the Meeting on the 3rd. inst. The Summons for that day of 1919 contains the item " To Ballot for as Candidates for Advancement, and, if elected, to advance the following Brethren ... " then follows names and details of no less than eleven Candidates, all of whon we've seeking advancement with a view to becoming Founders of a new/formed view the //opg auspices of the M.M. Masons who belonged to the Craft Lodge of the Mystic Quest. Ten of these brethren were present and advanced that evening.

This led to a discussion at another meeting of P.M's and Off's when the W.M. raised the question of a donation of one half of the Advancement Fees to the New Mark Lodge when formed. It was decided to supply the Mark clothing & ledel to the Canadates at a charge of two guineas each, and that they be asked to pay a subscription of one & one half guineas. Later, a portion of the Fees was donated to the New Lodge.

It was proposed at the Regular Meeting of 1st. March 1920 that 15. be taken from the Lodge Funds for the purpose of investment in five £. Shares in the Moseley Masonic Hall Co. Ltd., and a further one guinea be voted to the funde of the Worcestershire Masonic Library. This was seconded and accepted.

The Third Annual Report of the Charity Stewards presented to the Lodge on the evening of the Installation of Bro. James Lucking, P.G. R. of Mks., on 6th. Sept. 1920 is interleaved with the Minutes. A org other items, a report is given of receiving several distinguished brethrin as Joiring members, and of advancing no fewer than sixteen brethren into Mark Masonry it also states that the Ark Mariners Lodge was consecrated and is already a source's additional strength to the Mark Lodge and refers to the fact that the fit'v-scond Anniversary Festival of the Mark Benevolent Fund proved a report, and sum collected being £10050-10-0.

Following consideration to be Intermediale Meeting and in Forsuance of Notice of Motion: W.Bro. J. E. Folley proposed " that By Law No.2 be amended to increase the Advancement Fee to guineas and the innual Subscription to two guineas" also... Bro. H. Payson moved in amendment " that the Advancement Fee be four guineas; Joining Fee be two grineas and Supscription be two guineas. " On a vate the amendment was supported, put to the meeting as a Motion and carried.

The endeavours of the Lodye continued in a satisfactory manner, the years however taking their oll of value i members and on 5th. September 1921, Bro. Alfred Allen, Jr. P.P.G.D. was Installed as Morshipful Master of Moseley Mark Master Masons Lodge No.66 by Dispensation of the Most Worshipful Grand Master) he being at the time Worshipful Master of the Hertford Military Lodge No.408.

An Elergency Meeting was held on 28th. Sept., i.e. twenty three days later, when a Bellet was akin for four Candidates for Advancement which proved in their favour and the, were duly Obligated and admitted as Mark Master Masons. A Deputation of several Brethren, including those newly admitted, who were desirous of forming a Mark Masons Lodge at Stechford were received immediately afterwards. They presented a Petition to be supported by the Lodge which, by a unanimous decision was signed by W.Bro. Allen and his Senior and Junior Warders. Civilities were exchanged and the Meeting was closed No Summons, only a carbon copied Amended Agenda of Business, is attached with the Minutes; nor was the Meeting held by Dispensation. At the next Meeting on 7th. November, the Secretary was instructed to send a letter to R.W.Bro. Zaucheus Walker to say that it was the most fervent wish of the brethren that his indisposition was only temporary. He was suffering from a severe chill. The brethren of the Royal Ark Mariners Degree who were present asked that their sympathies be also expressed in the letter. It would seem that the meeting was of short duration, there being only the essential matters, no ceremony or other business.

The remainder of the year was quiet, and on 4th. September 1922, Bro. I. W. Mavad, P.P.G.St.B., S.W., M.E., was Installed as Worshipful Master in the presence of the Deputy Prov. G. Master, W.Bro. James Jones. The evening must have been somewhat overshaddowed by the reading of letters of resignation from nine Brethren of the Lodge.

W.Bro. W. B. Hammond, one of the Founders occupying the Office of S.W. it he Consecration, passed to The Grand Lodge Above some days before the meeting of March following. Many were the expressions of sympathetic respect and porroy at his demise.

The Installation Meeting of Sept. 3rd. 1923 was attended by bo . the R.W. Provincial Grand Mark Master and His Deputy, when Bro. Harry George Glavill was Installed by Dispensation of the Most Worshipful Grand Master. He not having served a paster of a Craft Lodge but having duly served the Office of Warder in a Lodge of Park Master Masons.

The tempo of the Moseley Lodge had been moving at a ceringly stealier pace over the latter two years. There was a reduction in the average attendance at the meetings and in the intake of candidates. I cannot determine the Lodge strength through lack of records (without checking each and every entry in the limites), however on the Summons for the meeting of September 6th. 1976 a list of members was printed, the very first one. It contained thirty-one range.

Bro. E. G. Apps, P.P.G. St.B, S.W., M.E., r.'s installed on 7st. Sept. 1924. Both the R.W. Prov. G. Mark Master and the Deputy Prov. C.M. Mascer again attending. The name of the latter is many times recorded as

At the meeting of January 5th. 192 > Motion was put to the brethren " that a sum not exceeding ten guineas be taken from the 1.30. Junds as a contribution to the 1925 Festival for the Royal Mason's Institution for Boys " and this was duly approved.

The Minutes of the P.M's and Off's Meeting held on February 5th. 1925, record that " It was decided to iccommend to Provincial Grand Lodge that Saturday, Oct. 31st. was the only available date for eltertaining Provincial Grand Lodge and that it was understood that our Regular Merting due on November 2nd. be held by Dispensation on that date. "

The March Sum one normally showed as an item of Business " To Ballot for a Worshipful Master ". "This was absent on that for March 2nd. 1925, but a Minute of that meeting reads..." "The Ballot was taken for the Wor. Master for the ensuing year and proved unanimous in invour of SBro. E. G. Apps. " No mention is made of the reason for the re-election of W.b.o. Apps and indeed, the Summons for the Sept. Meeting does not bear the usual INTALLTION of Bro..... and, for Business, " The Wor. Master with appoint an invest his Officers. ", which he did, re-appoining eleven Officers I o t of a total of eighteen.

The 34th. Replan Meeting held by Dispensation on Saturday, October 31st. as arranged, was opened at 2.50p.m. The only business conducted by the Lodge was the reading of the Dispensation, Circular and the Minutes and their approval, then the Risings and Closing. Immediately following, the Annual Meeting of Provincial Grand Mark Lodge was held at which a number of high ranking brethren attended from this and other Provinces. The final Lodge Minute reads " The Meeting was preceeded by a Luncheon at which The Right Wor.Bro. William Thomas Page, Provincial Grand Master presided."

The death of W.Bro. I. W. Maund, P.P.G.M.O., Founder and original J.O. of the Lodge /a was referred to in "Feeling Terms " by the Worshipful Master at the Meeting of March 1st. and the Brethren paid their respects to his memory.

W.Bro. E. G. Apps completed his two year term in Office when he Installed Bro. G. R. Bailey, P.P.G.St.B., S.W., M.E., into the Chair of Adoniram on the 6th.Sept.1926. It is evident that the newly appointed Reg'r of Marks, Bro. John Hill, took the duties of his Office very seriously, putting a protest in writing to the P.M's and Off's " against the manner in which the Register of Marks of the Lodge had been kept... circularised the brethren twice asking for particulars of Marks but seven brethren of the Lodge had failed to reply. " It was agreed to give him every support, with the result that two months later it was decided to purchase " a proper Lodge Register. "

According to the records, Bro. Hill was also accomplished in his Explanation of the Tracing Board.

During the meeting of March 7th. 1927, the Secretary read a letter from W.Bro. James Lucking tendering his resignation. He was one of the Founders and the Worshipful Master referred to the valuable services he had rendered the Lodg. oroposing that Bro. Lucking should be elected an Hon. Member of the Lodge. This proposal was carried unanimously.

The tenth anniversary of the consecration of the Lodge may be said to be the Meeting for the Installation of Bro. W. O. Perry.P.P.G.D.C., on 5th. Sept. 1927, although five days short of the full period. The ceremony was a lefted by 3. Brochren, 14 of / whom were Visitors. The 10th. Charity Balance Sheet was presented in which it was recorded that 25 guineas had been sent to The Mark Benevolent Fund to make a total of $\pounds341 - 5 - 0$ contributted in the ten years.

) The (attached) Income and Expenditure Account for the year nding 31st. August 1927 shows an expenditure of £72 / 7 / -, with a balance being encess of income of £1/7/6. This compares with that for 17th. August 1918, expenditure £124/ 16/ 6, and an excess balance of icome of £9 /5 /9.

In the period to date forty-five capildates had been idvanced into the Lodge and there had been five Joining Members.

The death of the Tyler, Bro. George Blaken re was reported with sincere regret by the W.M. at the Meeting of the 5th. March 1928. A replacement was proposed, seconded and approved on the 5th. November and on the .4th. December 1928, Bro. George Evans, Masonic Hall, Kings Heath, Valter Mason of the Arter Lodge No.2654, was Advanced as a Serving Brother by spicial Dispensation.

On the 3rd. of the previews September, Bro. Daniel Oakley, Prov.G.D.C., S.W.M.E., was Installed as Worshipt Master by Dispensation, he being Master of Godson Lodge of M.M.Masons No.3.0.

One of the it's acts of the Worshipful Master at the Meeting of the 7th. January 1929 was to refer in feeling terms to the death of the late W.Bro. James Jones, who as Prov. C. S.c. and later as Deputy Prov. G. Mark Master as an Hon. Member had been a constant actender throughout the years. The Prov. Grand Master appointed Dr. Percy Austin Roden to replace him as Deputy Prov. Grand Master and he too was no stranger to this Mark Jonge.

In the 2nd. Sep., 1929 Bro. WIlliam Douglas Thomson, P.P.G.I.Wks., S.W., M.E., was Inscalled as Wor. Master by Dispensation, not having served as Master in a Craft Lodge The death was reported that evening of yet another of the Founders, W.Bro. C. P.Perry, and his memory was honoured in the usual manner.

A copy of Suggested New By Laws are inserted with the Minutes of January 5th. 1931, which had later been approved by the General Board and the R W.Prov. (. M., in which Country Members are recognised and alterations have been made to the previous By Laws in that the Subscriptions, and Joining Fee for a Brother under a Foreign Jurisdiction have been increased, also a number of items are set down which previous had been ommitted. The thanks of the Lodge were " offered to the Norshipful Master for the care he had taken in the preparation of the New Bye Laws. "

A Mark Token had evidently been presented to the Museum for a letter was read at the meeting of the 2nd. March, which contained the thanks of the Grand Secretary, T. J. L. Lumley Smith for the Token.

V.W.Bro. C. D. Eaton, W.M., was well versed in the Grant as he is shown as P.M. 115. 408, 606, 629, 893, P.G.O. in the Mark Degree, and indeed was Installed as Prov. G.I of Worcestershire in 1934, as well at being Grand Prior of the Grand Priory of Worcestershire.

> The Summons for the Meeting of Jaluary 4th. 1932 contains, for the first time, a list of Hon. Members, fficers and Subscribing Past Masters in that order, whereas, previously only the latter bod been shown, and those only since November 1926. It also contains the Note "The Ark Mariners Lodge meets at 5.30p.m." which was I hour prior to the time of the M.M. Lodge opening. A Minute of the Meeting contains the following "Bro. Gledall proposed Bro. Thos. Hy. Court of the Premier Lodge, Tages, Nigeria, No 924 as a Joining member and he was admitted at the next Meeting bell in March.

Moseley Lodge of M.M.M's No.667

The 150th. Regular Meeting of the Moseley M.M.M's Lodge was opened on Monday, 1st. March 1954 by W.Bro. J. W. Thompson, P.G.D., P.D.G.W. (Bombay), Master, at the Masonic Hall, Kings Heath. He spoke " of the passing of The Late Most Worshipful Grand Master, Brig.Gen. W. H. V. Darell, C.B., C.M.G., D.S.O., whom he had known for 30 years. It was indeed a personal loss and would be shared by many with whom he came in contact in Craft and Mark Masonry. His wonderful personality established him as a Friend and Guide at all times. He was a Great Mason . All present stood in silence as a tribute to his memory. "

The W.M. also announced that " It was his intention to extend an invitation to <u>AXTENNIXAN</u> all Members of the Moseley Lodge of M.M.Masons to bring their Ladies and visit his home, there to be received by his Wife and himself for an afternoon Garden Party during the sunny period of June or July. " His home was at No 4, Norfolk Road, Edgbaston.

The Right Worshipful Grand Master of the Province, W.Bro. V. H. Grosveno, Ll.B., J.P., was present and referred to a rewritten Book of Constitutions, considering it " a far better job. "

Ladies Nights had been held regularly through the years usually following the Regular Meeting in June. The Worshipful Master said he did not know what prangements were being made for one this year but, as the first monday in June full of the Whit Bank Holiday it would have to be held on the 14th. June by Jupersation.

The June meeting was accordingly held on that date and one of the first Minutes reads "Right W.Bro. V. W. Grosvenor, Ll.B., J.P. 1.G.D., Right Worshipful Provincial Grand Master was saluted with Honours 7, To which be responded. The W. Master extended congratulations to The Prot. G. Ma.te. on his promotion to Past Grand Deacon of the United Grand Lodgs of England. V.M.Bro. H. E. Clive, O.B.E., was also congratulated on his promotion to opst Grand Overseer. "The W.Master later spoke of Candidates "All present were reminded Now necessary it was for the right Candidates to be introduced for on future, we need at least two Candidates next year - particularly the type who would prograss through the various offices in the Lodge and so help future Master, during their year in the Chair. "

It was also reported the Grana Lodge Tuilding Fund had been used to purchase a another building at Brock Striet in the West End as the present total was inadequate to build a new home. There would be a better Lodge room and Office facilities in the new premises.

The following Meeting of the 6ch. September was for the Installation of Bro. R. Barton, S.W., Master Elect. Following the reading of the Minutes of the 150th. Meeting " The howor. Prov. G. Master said that before putting the Minutes forward as regards their accuracy he was sure the brethren would agree that they had heard an interesting recording, somewhat different to the usual set and rigid Minutes so often in turned in Longe Meetings. "

The example of a reconably full and clear recording of what took place was copied by succeeding for taries for a number of years. Their efforts have rendered the writing of the Leage History so much easier for which the writer is extremely grateful and which I hope future Secretaries will bear in mind for the benefit of later historians.

Arising from the Minutes, the brethren were advised that the new Book of Constitutions would be ready by Jan. 1955 and that a new Chant Book would soon be available, which W.Bro. W. Stanley Bloore, Prov. G. Sec. thoroughly recommended.

In the Almoner's Report, W.Bro. C. B. Robinson reported an opening balance of $\pounds74-18-6d$. and that "we now have on hand $\pounds82-17-6$." A grant of $\pounds25$. had been made to a Widow which the W.Master said was most satisfactory, repeating what he had said many times that he was completely in favour of dispensing Charity.

The Minutes having been read , confirmed & signed and Honours given to the Nigh * Manking Brethren, " The Rt.Wor.Prov.Gd. Master then stated that at inis part of the pro ceedings it was customary for him to hand over the Gavel to the Marter of the Lodge, but at the request of the Wor.Master, who was heavily engaged in Masonic Duties in another Degree, he was pleased to agree to Installing the num Master " An evening to remember for W.Bro. On that same meeting of the 5th. March, "W.Bro. V. Rawson announced the date of the Warwickshire Mark Lodge of Instruction Festral which this year he said had a particular interest for our members because the 'applain of the Lodge, V.W.Bro. H. E. Clive, had been invited to preside con this very popular annual event, which had become an important date in Midlard Cark Masonry. "

The Prov. Grand Master, attended by Mildro. F. I. Wriffiths, Prov. G.D. of C., was escorted into the Lodge to witness the Installation of Bro. S. N. A. Heaven at the Meeting of 3rd. September 1956 and was given his full honours. He took a smaller part in the ceremony than he d d the provious year, only giving the Address to the new Worshipful Master. One itom gave W. Bro. S.N.A. Heaven particular pleasure that evening when he proposed that a sum of 15 guineas from the Ladies Festival Funds be passed to the Almone. for his "harities.

We find two Heaven on the successive Summonses for this year of Office as Bro. K. V. R. Heaven was invested Secretary of the Lodge.

The December Liveling saw a useful addition to the Lodge membership as two Candidates were advance. Fros. Bortion Warner and Dudley Newman Sadler, M.B.E. as well as Bro. Edwird James Ashfield being accepted as a Joining Serving Brother to become Tyler sevin meeting. later.

A copy of the Stamol's is missing from the Minutes of the Installation Meeting of 2.1. September 19,7, when Bro. Sydney Frieder was Installed as Wor. Master. The evening W.Bro. W. P. Beck reported on a visit to Ryon Hill " and stated that a book had be a presented to the Lodge by W.Bro. Adams. " The title of the book is not mentioned but latter day Msons may be interested in Ryon Hill. Ryon Hill was a gift to the Province of Warwickshire by W.Bro. E. J. Hardy, P.P.G.P., in 1947. This fine mansion served a useful purpose as a Masonic Home until overheads and running costs became too high which led to it being closed in May 1966 and sold shortly afterwards. In the meantime, a new Royal Masonic Home was built at Qadby, Leicester and received the inmates of Ryon Hill on its closure. This new purpose built, architect designed, medically equipped Home named Devonshire Court was officially opehed by Her Majesty, Queen Elizabeth, the Queen Mother, on 2nd. Nov. 1966. Brethren would find it well worth a visit to see the excellent provision made for the comfort of elderly and infirm Freemasons and their families.

The Deputy Prov.G.Master,V.W.Bro. S. Burton,P.G.Ov., represented the Prov. G. Master who was ill, giving a report of his very good progress after a period of recuperation in the Isle of Weight. The R.W. Provincial Grand Master was sufficiently recovered to attend the next meeting of the 1st. December 1958, when Bro. Albert Atack of Stratford Road, Hall Green. Birmingham, was Advanced.

The year of 1959 progressed quietly and Bro. Eric Meith Palmer was Installed at the meeting of 7th. September. The Summons for the meeting of 7th. December 1959 and the one for the following meeting differ in paper and colour to the astal which came back into circulation for the one later meeting. The Minutes for the meeting of 7th. Dec., record that Bro. D.A.R. Thomas was proposed by Bro.K. N. V. ? Heaven (a slip of the pen perhaps). Bro. Thomas was Advanced, tog, ther with W.Bro. Norman Bragg, Prov.A.G.D.C., on the 7th. March 1960.

The loss of the Tyler of the Lodge was reported to the Meeting of 30th.May '900, and the Brethren stood in silence in memory of Bro. E. J. Ashfield. This Office was filled by Bro. H. Boynton whose name is given as such in the Mirut's of 5th. December 1960, although not on the Summons 'till the fill ing Mirut's but, there is no record of him being proposed, seconded and elected until the reeting of 5th. June 1961.

Referring back to the Minutes of December 1960 1 oute " In Acting Secretary reported receipt of communications from the Prov. J. Secretary advising that due to ill health R.W.Bro. V. W. Grosvenor had relictantly bee, compelled to resign as Prov. G. Master also that V.W.Fro. W.S. Billion, Dep.Prov.G. Master had been appointed to succed R.W.Bro. Grosvinor as Prov. G. Master. "

It is recorded for the meeting of the oth. March 1961 " V.W.Bro. H. E. Clive, O.B.E., P.G.Ov., reminded Brethren of the forth coming Special Meeting of Provincial Grand Lodge on Friday, March 13/10. The V.W. Pro. W. S. Burton would be installed as Provincial Grand Master by the W.W. The Cland Master, The Rt.Hon. Lord Harris, M.C., V.L., and hoped that as many Brethren is possible would support the Wor. Master by attending on this menorably occasion. "

Right W.Bro. V. W. Grossen or, C.B.F., P.T.G.Master was reported to have passed away by the Worshipful Masterafter opening the meeting of the 4th. September 1961, giving a tribute to him for his many services to Masonry and called upon all Brethren to show a mark of their esteem and regard.

The Installation of James Henry Bird, S.W., Master Elect then took place, by Dispensation. V.W.Bro. F. H. Griffiths, P.G.Ov., Prov.G.D.C., tendered hearty greetings from Provincial G. Lodge.

The R.W. Prov. G. Mister, R.W.Bro. W. B. Burton, attended the following Meeting on 4th. December 1701 and gave his congratulations to the Worshipful Master and his Officer: for an excellent ceremony, which was the Advancement of Bro. Thomas Clement Sain bury of Sally Oak.

The Worshiph 1 Master gave Notice of Motion at the meeting that at the next Regular Meeting he would propose " that the Bye Laws be altered to permit of the Installation Meeting being held on the fourth Monday in September instead of the first Monday in September as at present. "
