WHEREAS Our trusty and well beloved Companions James Rock, Martin Meara, John Boyse, William Folds, Edward Moore, John Kimmins, Alexander Dudgeon, Joseph Hanly, George James Baldwin having besought us to empower them to hold a Royal Arch Chapter to be attached to the Freemason Lodge No. 50 on the Registry of Ireland to be holden by them and their Successors lawfully admitted.

We duly considering the premises do by these presents Authorise and constitute the above named Companions and their Successors the Officers of a Chapter of Royal Arch Masons to be attached to the said No. 50 and to be holden at Dublin in the County of Dublin with full power to perform all Acts befitting a lawful Chapter of Royal Arch Masons PROVIDED ALWAYS that such Acts shall be in strict conformity to the Rules and Regulations now existing or hereafter to be made by the Grand Royal Arch Chapter of Ireland reserving to us and our Successors the right of deciding all differences and of annulling or cancelling these presents if we shall deem it necessary.

BY-LAWS

OF

Royal Arch Chapter, 50

(St. Patrick's.)

I.

The Stated Convocation of this Chapter shall be held on the first Thursday in the months of February and April, and the second Thursday in months of October and December, at the hour of Five o'clock, p.m. The E.:K. or in his absence the H.:P.: and C.:S.: shall have power to direct a chapter of Emergency to be summoned whenever it may be necessary in accordance with G.R.A.C. Rule 38.

II.

The Fees in this Chapter shall be as follows, and shall be payable in advance:—

III.

Any Companion whose subscription shall be more than twelve months in arrear shall not be entitled to any of the privileges of membership, and shall be liable to have his name removed from the List of Members in accordance with S.G.R.A.C. Rule 54.

IV.

Candidate for Exaltation, Affiliation or Re-Admission, shall be admitted by Ballot. One Black Bean to exclude.

V.

The Officers of the Chapter shall be elected at the Stated Convocation in the month of October in each year, and no Companion shall be eligible for promotion unless he shall have attended at least Two Convocations of the Chapter within the twelve months preceding the October Meeting.

VI.

The Registrar shall keep the Minutes, Register and summon the Members, make all returns required by Grand Chapter, and at the October Meeting furnish a statement showing the attendance of each member for the previous twelve months. The Treasurer shall receive all dues, make all payments ordered by the Chapter, keep the Accounts which shall be balanced to the 31st day of December in each year, and shall be audited and presented with the Auditor's Report at the February Meeting. A Bank Account shall be kept, and all monies lodged to the Credit of said Account. The Books of the Registrar and Treasurer shall be on the table at all Stated Convocations.

VII.

No Motion for the amendment or repeal of these By-Laws or for the addition of a new one shall be entertained, unless written Notice thereof has been handed in at a previous Stated Convocation, nor shall it be passed without two-thirds majority of those present, and voting, and no alteration shall take effect until confirmed at the next Stated Convocation. All such Notices of Motion shall be inserted in the Summons for the Convocation at which the matter is to be discussed. All Communications shall be sent out by the Registrar at least Seven days previous to the day of Meeting.

VIII.

A Committee, consisting of the E.K.H.P., C.S. Registrar and Treasurer, and one other Member to be elected by the Chapter, three to form a quorum, shall have charge of all arrangements for Refreshments.
