## BY LAWS or CODDSOD LODDCE Mr. 2385 ANTIENT FREE AND ACCEPTED MASONS FOUNDED 1890

PREAMBLE This Lodge acknowledges the scoremacy of the vited Grand Lodge of England, the authority of the wincial Grand Lodge of Norcestershire and ug of the Book of Constitutions. United Grand Lodge of England, the authority of the Provincial Grand Longe of Worcestershire and the ruling of the Book of Constitutions.

## BY-LAWS OF GODSON LODGE No. 2385

I. The Lodge shall meet at the Talbot Hotel, Oldbury, on the fourth Wednesday in January, February, March, April, September, October and November, and the third Wednesday in December, at such hour as the Master may direct.

2. The Master and the Treasurer shall be elected by ballot, and the Tyler by a show of fands at the regular meeting in February. The Master Elect shall be installed at the regular feeting in March.

3. The Lodge Committee shall consist of the Master, Wardens, Past Master, Treastrer, Secretary, and Stewards if appointed. This committee shall consider and report to the Lodge on all proposals for membership and any datter, specially referred to it by the Lodge. The budit Committee shall consist of the Master, the Dynedia Past Master, Wardens, and two members to be cleated at the March meeting. The accounts shall be made up to the last day in February and presented to the March meeting.

4. The mitiation fee shall be twenty guineas, the joining fee seven guineas, the rejoining fee five guineas and the annual subscription seven guineas, the value in advance in March), except in the case of country members (see By-Law No. 5) X. The Master shall have the privilege of inviting to the dinners guests to a total of twelve for the year without payment, six of whom may be his to installation. Such invitations shall be exclusive of the official invitations of the Lodge. Any Brother whose

subscription is unpaid for more than one year shall be liable to be excluded from the Lodge, in accordance with Rule 181. Book of Constitutions.

5. Members of the Lodge who neither reside noncarry on business, nor have any address within twenty miles of the Talbot Hotel, Oldbury, or any Brother who shall be approved by the Lodge, who have paid all dues and the regular Lodge lees for two years in succession may, on application in writing, be continued as Members, with the usual privileges, for an annual subscription of two and a half guineas, and such Dining Fee as may be fixed from time to time by the Lodge.

6. The election of Candidates or initiation and joining shall be conducted in conformity with the requirements of Rule 157 to 166 Book of Constitutions. On the halot to Candidate one black ball shall exclude

7. A Memory desired of terminating his membership of the Lodge call tender his resignation in writing, orally in open Lodge, and he shall be entitled the Cortificate mentioned in Rule 175 Book Controlutions, stating the circumstances in which be left the Lodge.

A for other than ordinary purposes, may be made only by resolution of the Lodge, of which notice has been given in the summons ,except in case of emergency, when such payment may be authorised by the Master, and confirmed by the Lodge at the next regular meeting. 9. Addition, alteration or amendment to these By-Laws or any of them, shall be made by notice of motion given in open Lodge at one regular meeting, or to the Secretary in writing not less than fourteen days before the next meeting, for insertion in the summons. The notice shall be considered at that meeting, and, if then approved, shall be submitted for confirmation at the next regular meeting, but shall not become effective until finally approved by the Provincial Grand Master and the May Grand Master.

10. These By-Laws shall be read in oper Fodge once at least in every year at such time as the Master may deem most convenient.

NOTE.—Should there be any objection to the introduction of a Candidate for obtitation or a Brother for Joining, it is recommended that such objection be mentioned privately to the Master or Secretary, who may communicate with the proposer and give him the opportunity of withdrawing his Candidate.
