# BY-LAWS

OF THE  
 Provincial Grand ~~Conclave~~ <sup>Priory</sup> of Knights Templar,

WORCESTERSHIRE.

THE Members of this Provincial Grand ~~Conclave~~ <sup>Priory</sup> do hereby resolve, that in all things not especially provided for in the Statutes of the Grand ~~Conclave~~ <sup>Priory</sup> of England and Wales, they will be guided and governed by the following By-laws:—

## I.

That the Provincial Grand ~~Conclave~~ <sup>Priory</sup> shall meet at least once in every year, at such time and place, as the Provincial Grand ~~Commander~~ <sup>Prior</sup> shall appoint.

## II.

That every Sir Knight shall on his first appointment to office pay towards the funds of the Provincial Grand ~~Conclave~~ <sup>Priory</sup> as follows:

The Prov. Grand, <del>Prior, Prolate, and Captains</del> <sup>Grand Priorate, Chan. allow Comtable</sup> .....	1	1	0 each
All other Officers below that of <del>Captain</del> <sup>Marshall</sup> .....	0	10	6 each

The Fees for promotion from one office to another shall be 10s.6d. and below the rank of ~~Captain~~ <sup>Marshall</sup> 5s.

### III.

That any Provincial Grand Officer, who shall be absent from Provincial Grand ~~Conclave~~<sup>Prior</sup>, and who shall omit to send a valid excuse in writing to the Provincial Grand ~~Commander~~<sup>Prior</sup> previous to the hour of meeting, shall be fined Five Shillings.

### IV.

The fees payable to the funds by each ~~Encampment~~<sup>Prior</sup> in the Province shall be :—

For every Knight installed .....	0	5	0
For every Member joining .....	0	2	6
For every Dispensation .....	0	5	0
*For every annual Sub. for each Member .....	0	1	0

\* This is not payable for the year in which the Member shall be first registered.

### V.

No Sir Knight shall be allowed to rank as Past Grand Officer unless he has duly served his office, and paid his appointed fee.

### VI.

Every ~~Encampment~~<sup>Prior</sup> shall on or before the 31st day of March in every year, make a return to the P. G. ~~Conclave~~<sup>Prior</sup> of all its members, and pay the fees as above.

### VII.

The accounts of the P. G. Treasurer shall be audited and passed annually, previous to the election of his successor.
