## The Birth of an Idea that became an Ideal

From existing records connected with the Lodge, one gathers that in 1925 three Brethren of an existing Lodge conceived the desire to be Members of a small body of Freemasons, who would be mainly interested in pure Masonry than in the social amenities. They approached Wor. Bro. DR. GEORGE THOMAS in November, 1925, with a view to him becoming their master if the ideal they held received his accord. The ideals were also those held by our First Master, who, though appreciating the tremendous task of forming a new Lodge, gathered around other Brethren to join with him and the three originators.

Meetings were held at which the Petition for the proposed Lodge was agreed. Additionally, the Principles and Ideals were drafted before the Consecration. Copies of these are given in extenso for all Brethren to read and digest.

### *Principles and Ideals*

#### LAI D DOWN AND ADOPTED BY THE FOUNDERS OF THE LODGE OF ST. FRANCIS No. 4899, PRIOR TO ITS CONSECRATION.

1. The Lodge shall be very small, aiming at "quality" rather than "quantity."
2. For the same reason it shall be very "exclusive"; being open only to those who are known to be fired with the "genuine Spirit of Freemasonry" and a keen desire for perfection in the work of the Lodge, and are prepared to do all in their power to give expression to the true spirit of Masonry in its most ample sense, and to make sacrifices to that end.
3. It shall be a Lodge of the very strictest moderation as regards its banquet, even to the point of frugality.  
(N.P. This would deter an undesirable element from seeking admission to the Lodge).
4. That Dignity, which should at all times distinguish Masonic proceedings, shall be strictly observed, both in the Lodge Room and Dining-Room.
5. Noisy behaviour, shouting or other ribald hilarity, shall not be tolerated, and "challenging" shall only be in moderation, and with due decorum.
6. The Brethren must show "HUMILITY," "ZEAL," and "TOLERATION."

7. It shall be a Lodge of "UNITY" and "EQUALITY," and an air of superiority shall not be tolerated, and any brother who manifests such attitude, no matter what his rank or office, may be called upon to resign from the Lodge.
8. Any Brother failing conspicuously in our ideals, or indulging in conduct contrary to those ideals, or acting in any manner likely to bring discredit upon the Lodge, may be requested to resign.
9. No one can be admitted a member of the Lodge unless all the members are satisfied that such a one is prompted by the same high ideals as are herein laid down, and is prepared to eliminate all motives of personal aggrandisement, and work with that unity, zeal and harmony, without which we cannot achieve our ideals.
10. That our motto shall be :—" FOR SERVICE."
11. All Founders must be unanimously elected by those already elected, and will be selected with the utmost care, having regard to their qualifications to fit in with our high conceptions and ideals.
12. That the number of Founders shall be limited to fifteen.
13. That the expense of founding the Lodge shall be borne equally by the fifteen Founders.
14. No office, or other favour, shall be promised, offered, implied or granted to any Founder or member on account of his making any contribution toward the expense of founding the Lodge or its upkeep.
15. The first list of Officers shall be at the sole discretion of the first Master ; he having regard only to the capability and desirability in the Master's opinion of Brethren to fill the offices to which they may be called.
16. Founders, or members, of whatever rank or office in any other Lodge, may, at the sole discretion of the first Master, be omitted from office, or requested to accept junior office in this Lodge, and they will be expected to cheerfully accept any such office that it may please the Master to offer them, and to work for the achievement of our ideals and the success of the Lodge and the Craft without thought of personal advancement.  
(N.B. It is the success of the Lodge and the Craft that matters—  
not the individual.)
17. All the members of the Lodge must make themselves proficient in the work of the Lodge.
18. All members must give an undertaking to learn the work, so far as lies within their capacity, and plead no excuse save that of illness.



19. Any member failing to carry out the above clause may be requested to resign.
20. All Brethren must give proof of their ability to do the work before appointment to any office.
21. Promotion of the Lodge can only be obtained by *seniority combined with efficiency*.
22. Brethren failing to keep their work up to the highest standard of efficiency will not be retained in office.
23. The Lodge shall not be made expensive ; but Brethren will be expected to make reasonable sacrifices.
24. The number of members shall not exceed Forty.
25. Candidates for Initiation shall be strictly restricted to those who are known to possess those characteristics peculiar to our Lodge ; besides conforming in all other respects to the usual standard of qualifications required by the Craft. Such Candidates will be required to attend a joint Meeting of the Master, Past Masters, Officers, and Founders of the Lodge, who shall enquire very searchingly into the Candidates' qualifications for admittance into the Lodge. Such Initiates shall be strictly limited to not more than three per session.
26. Brethren wishing to become Joining Members will have to undergo a similar examination by the Committee of Enquiry.

### *Petition*

Having conceived the idea, laid down the principles and visualised the ideals of this small body of craftsmen, the Founders then Petitioned for a Charter or Warrant of the proposed Lodge. Here follows a copy of the letter accompanying the Petition and the names of the Petitioners :

#### **TO THE PROVINCIAL GRAND MASTER OF WARWICKSHIRE :**

The Petitioners for this Charter are a body of Freemasons, who are more interested in pure Masonry than in the social amenities, following the usual Lodge Meeting, and are animated by the desire to obtain greater facilities for pursuing Masonic studies than are at present available for them, that they may develop the intellectual side of the Craft.

It is intended that at every Meeting, excepting Installation Meetings, a short paper shall be read, or lecture given, on some subject of Masonic interest, by which means we hope to make advancement in Masonic knowledge.

The Petitioners desire to meet at such time in the evening, say six o'clock, or six-thirty o'clock, as shall not necessitate their leaving business to attend the Lodge, and, by curtailment of the after proceedings, the Meetings would terminate earlier than usual. Moreover, in place of expending the Lodge funds in social amenities, it is intended, by self denial, to extend the contributions to the three Masonic Charities, collectively, in greater measure than a Lodge would normally be able to do. The Petitioners desire to be formed into a Regular Lodge of which the outstanding characteristics shall be "Service and Sacrifice" in this way following the noble example of the Patron Saint of the proposed Lodge.

Emulation working would be strictly adhered to. It is intended that a Past Master shall not take the Chair, with the exception of the first and possibly, second Master, so that those Brethren who have not passed the Chair, may be provided with an opportunity of attaining it.

It is intended not to initiate more than three candidates per Session, that their progress in Masonry may not be unduly retarded.

The Petitioners desire to meet temporarily at the Masonic Hall, Erdington, Birmingham, until such time as a suitable opportunity presents, of meeting at the new Masonic Temple.

## *From the Foundation Stone*

### THE MASONIC WORKSHOP
